Each RSU represents the right to receive one share of Encore common stock. These 5,931 RSUs are not subject to vesting.
- Reflects shares of Encore Capital Group, Inc.'s common stock held by JCF FPK I LP. By way of his position as investment co-head of FPK Capital and his interest in Fox-Pitt Kelton Limited, a limited partner of JCF FPK I LP, Mr. Hanford may be deemed to be the beneficial owner of these shares through his pecuniary interest in JCF FPK I LP. Mr. Hanford disclaims beneficial ownership of these shares in excess of his pecuniary interest therein.
